AI National: Professional Standards and Guidance Committee - PSGC Susan Curran, MAI, AI-GRS

It has been an honor to serve on this Committee for the past three years, under Chairs Paula Konikoff JD, MAI, AI-GRS, and AI Past President Jim Murrett MAI,SRA. Fortunately, I got to attend three January meetings in Chicago, in person, including the "chilly" Polar Vortex meeting of 2019.

PSGC is known as one of the AI "Working Committees" and I have learned a great deal about existing and proposed AI Guide Notes, proposed updates to various definitions and language within the AI Code of Professional Ethics CPE, and AI feedback on new USPAP Exposure Drafts.

The focus early this year was on language changes for the CPE on the terms "Service", "Valuation Practice" and "Valuer", proposals for language in Draft Al Guide Note "Consideration of Leases in Fee Simple Valuation", proposed revisions to draft Guide Note Performing evaluations of Real Property Collateral for Lenders, and Al initial comments on the first USPAP Exposure Draft for the 2022—2023 edition. One concern noted in the proposed USPAP draft is a revision to the Definition of Appraiser: "An Appraiser is expected to comply with USPAP". Al opposes this statement as it believes that an appraiser may choose to not comply with USPAP if they are performing a role in a valuation service other than being an appraiser.

A few months later, an Anti-Bias Workgroup was formed. This group, including PSGC Committee Member and Al Director of Ethics and Screening Stephanie Coleman MAI, SRA, AI-GRS, AI-RRS, drafted a new Guide Note on Personal Characteristics and Valuation Practice, and new Ethics Rule 1-5 language stating a prohibition on basing an opinion of value, developing an opinion of value, and transmitting a report based, either partly or completely, on personal characteristics or any protected characteristic under applicable law and unsupported conclusions. A new definition of "Personal Characteristics "was also drafted for discussion, and an "Aspirational Code" Workgroup was formed to develop language on professional behavior.

At the November 2020 Board of Directors meeting, the Proposed Amendment to CPE was heard and questions submitted back to PSCG for comment. Also, at this meeting, the Board approved and adopted the Compliance with the Code of Professional Ethics and standards of Professional Practice of the Appraisal Institute. PSGC has not yet submitted the draft Guide Note on Personal Characteristics and Valuation Practice for BOD consideration although this is being considered for the Winter Board Meeting 2021.

It has been a pleasure to serve on the PSGC for AI over the past three years with terrific and dedicated Committee members from all over the US. I have also enjoyed getting to know Stephanie Coleman, a true professional as well as a brilliant and capable asset to AI and all its members and affiliates.

# Government Relations Chris Bourland, MAI

Various governmental entities have been drafting rules, policies, and procedures throughout 2020 which affect both the way we conduct business as real estate appraisers and how we behave as individual citizens. The mandates often change with little notice, so below is a summary of recent actions that may impact real estate appraisers and our businesses.

Recently, the Pennsylvania Department of Health announced additional rules aimed to hamper the rapid increase of COVID-19 cases and hospitalizations. Effective November 18, 2020, Governor Wolf enacted a universal mask mandate, requiring every individual, age two and older, to wear a face mask when indoors if another person is present. It should be clear that while on property inspections, appraisers must wear masks.

The order also mandates businesses to "require that all people, including their employees, customers... and visitors, wear a face covering and take reasonable steps to enforce the requirement." Businesses must also post



signs of the masking rules. See: https://www.governor.pa.gov/wp-

Effective November 23, 2023, Governor Wolf issued a stayat-home advisory as well as additional orders relevant to real estate appraisers. Governor Wolf ordered remote or telework, unless impossible.

Businesses that maintain in-person activity in their office must implement a temperature screening for all employees before entering the building and refuse entry to anyone with a temperature above 100.4 degrees. Additional cleaning protocols are also required, and businesses should maintain records identifying whether any employees or customers have been in close contact with anyone diagnosed with COVID-19.

# Candidate Guidance Update Ed Falkowski III, MAI, SRA

Despite the tumult that 2020 has brought with it, the Candidate Guidance Committee has good news to report! First, two of our previous Student Affiliates, both from Temple University, have upgraded their statuses to Practicing Affiliates! Secondly, during our "virtual visit" to Temple back in late October, we were successful in getting three additional students to enroll as Student Affiliates! Temple never ceases to amaze us at the quality students that they produce in the real estate space and we look forward to continuing that relationship for years to come. As always, I am truly fortunate to have the best possible team to work with – Christin Phillips, MAI, Walt Krzywicki, MAI, AI-GRS and Joe Sisson, MAI – without their efforts, support and tremendous presentation skills, the results that we've been able to obtain would be nowhere near as successful.

Back in mid-October, I led a "virtual real estate boot camp" at Penn State University which was made possible by the tireless effort of our own Mike Mignogna, MAI, AI-GRS. I was able to present our real estate valuation overview to the students and it was well received by the students and faculty alike. Afterwards, Penn State reached out to several of our members to participate in a PSU job fair. Our chapter President, John Crognale, MAI, reported that there was substantial interest in real estate valuation at the job fair and believes that this will be a very fruitful relationship with

Penn State. We're hoping that, in a safe and healthy environment, we can take a trip to Happy Valley in 2021 and present to the students in person.

Finally, at the national level, the University Relations Committee (URC) is embarking on its main initiative to get more Al designated appraisers in front of colleges and universities to further educate students about the real estate valuation profession. To that end, the Appraisal Institute is working with The Appraisal Foundation (TAF) and the Appraisal Qualifications Board (AQB) to assist more colleges and universities in navigating the accreditation process for TAF's "Real Estate Degree Review Program". As a quick refresher, this program allows students to graduate with substantial amount of licensure qualifying education already completed. Temple (May 2020 - up to 258 hours) and Penn State (April 2020 - up to 258 hours) have recently been accredited and they join Lehigh University (renewed May 2020 - up to 273 hours) as the only Universities in Pennsylvania with AQB accreditation. The URC, in less than a week after the initiative's launch, already has a university in New York which has expressed interest in going through AQB accreditation and is in advanced discussions with them. I have been tapped to be the primary liaison between the AI and TAF/AQB for this initiative and look forward to really getting this effort going. There is much more to come on this front but we're certainly off to an exciting start!
